School Budget was discussed. Janet informed the Board that at the District Budget Meeting, the budget was raised up approximately \$65,000. Ratification vote on this will be next Tuesday, June 8, 2010.

It was noted that the Board still does not have a proposed budget from the **Randolph Fire Department**.

County tax was discussed.

Community Benefits were discussed. It was discussed that possibly Janice's Food Pantry would be increased by \$200.00 and Chrysalis Place would be decreased by \$200.00. Tabled for more information.

Ed is going to work with the Treasurer for definite figures on Article 33 (Contracted Services).

Questions on the Building & Lands account will be discussed with John Crocker.

General Assistance budget was discussed again. Discussion at previous meeting was to cut this figure.

20-25 – are all Fire Department items.

Article 18 – waiting for Trash Pick Up figures.

Article 16 – Greg Lumbert, Animal Control and Code Enforcement to stay the same.

Article 15 – need to check for balance on this account.(Public Works Vehicle Replacement).

Peter Hanley stated that he will call Al Smith to see if he will serve as moderator for Town Meeting again this year.
